- 01. The *Gazette Extraordinary* No. 1813/14 dated 05.06.2013 issued to publish a list of items subject to import control was passed by the Parliament on 09.07.2013;
- 02. The *Gazette Extraordinary* No. 1813/15 dated 05.06.2013 issued making it mandatory to comply with Sri Lanka standard specifications for exported cinnamon was passed by the Parliament on 09.07.2013 ;
- 03. The *Gazette Extraordinary* No. 1819/32 dated 18.07.2013 issued to rescind the *Gazette Extraordinary* No. 1764/9 dated 27.06.2012 issued to limit exportation of rice was passed by the Parliament on 22.08.2013;
- 04. The *Gazette Extraordinary* No. 1821/40 dated 01.08.2013 issued to control importation or exportation of Hydro Chloro fluoro Carbons (HCFC) was passed by the Parliament on 03.09.2013 ;
- 05. The *Gazette Extraordinary* No. 1837/41 dated 21.11.2013 issued by including new HS Codes and repealing the existing HS Codes in respect of the vehicles imported to Sri Lanka with the objective of transporting passengers and goods was passed by the Parliament on 20.12.2013 ;
- 06. The *Gazette Extraordinary* No. 1843/40 dated 02.01.2014 issued by amending the effective date of the *Gazette Extraordinary* No. 1813/15 dated 05.06.2013 issued making it mandatory to comply with Sri Lanka Standard Specifications for exported cinnamon was passed by the Parliament on 22.01.2014 ;
- 07. The *Gazette Extraordinary* No. 1844/49 dated 08.01.2014 issued making it mandatory to comply with Sri Lanka Standard Specifications for 123 imported items was passed by the Parliament on 22.01.2014;
- 08. The *Gazette Extraordinary* No. 1846/16 dated 21.01.2014 issued by including new HS Codes and repealing the existing HS Codes in respect of the vehicles imported to Sri Lanka with the objective of transporting goods was passed by the Parliament on 04.03.2014 ;
