#### Regulations

1. These regulations may be cited asImport and Export (Control)Regulations No. 04 of 2014 and these regulations are effective from 1<sup>st</sup> of August 2014.



Provided that the licenses issued before 1st of Augus2014, under the formats of C.I.E.01 and C.I.E. 02 which have been enforced by Import and Export (Control) Regulations No.02 of 2002, shall be valid and enforced in order to issue licenses and fulfill rights and obligations included.

- 2. Controller General of Import and Export shall use the format mentioned in the annexure 01 in place of the formats C.I.E. 01 and C. I.E. 02 used currently to issue Import and Export Control Licenses under the section 7 (2) of the Import and Export (Control) Act.
- 3. The format of debiting form issued after debiting goods imported under the Import and Export license shall be used as mentioned in the annexure 02.
