## Gazette Extraordinary Notification No. 2171/5 dated April 16, 2020

The following directions are issued under the power vested in Imports and Exports Control Act No. 10f 1969 and in terms of the regulations No 6 of the Gazette Extraordinary No. 2171/5 dated April 16, 2020.

- 1. Sri Lanka Customs shall charge penalty and release goods stipulated in schedule I of the Gazette Extraordinary No. 2171/5 dated 16.04.2020 and were shipped during the period from 18.04.2020 to 21.05.2020 subject to payment which is effected after 120 days from the date onboard.
- 2. Banks shall effect payments after 120 days from the date onboard in the instance mentioned above 1.
- 3. The directions mentioned in 1 and 2 above are not applicable for the importations which have been approved by the Controller General of Imports and Exports.
- 4. However, deviations will not be granted for clearance of goods stipulated schedule II of the Gazette Extraordinary No. 2171/5 dated April 16, 2020 and shipped during the period from 18.04.2020 to 21.05.2020. Such goods should only be cleared on a 90-day credit facility as mentioned in the Gazette Extraordinary No. 2171/5 dated 16.04.2020.
- 5. Banks shall effect payments after 90 days from the date onboard in the instance mentioned above 4.

I would much appreciate if these directions could be implemented with immediate effect.
