Government Notifications

IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with sub-section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act, No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as the Imports and Exports (Control) Regulations No. 08 of 2020.
2. The Regulations prescribed in this *Gazette* shall only be applicable to importation of goods which have the date of Bill of Lading/ Air Waybill on or after 19 October 2020.
3. The following items and their corresponding entries described in the **Schedule I** of the Imports and Exports (Control) Regulations No. 04 of 2020, published in the *Gazette Extraordinary* No. 2184/21 dated 16 July 2020 are hereby deleted from that Schedule and following items are included in to the **Schedule II** of the *Gazette*.
