Government Notifications

IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance, promulgate following Regulations.

Regulations

- 1. These Regulations may be cited as "Imports and Exports (Control) Regulations No. 03 of 2021".
- 2. The Imports and Exports (Control) Regulations No. 02 of 2021 published in the *Gazette Extraordinary* No. 2213/8 is hereby repealed. By this means, "Imports and Exports (Control) Regulations No. 04 of 2020", published in the *Gazette Extraordinary* No. 2184/21 dated 16 July 2020 and "Special Import License Regulations", published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017 are in force without any effect of amendments made by the repealed "Imports and Exports (Control) Regulations No. 02 of 2021", published in the *Gazette Extraordinary* No. 2213/8 dated 02 February 2021.

 - 3. The Regulation Nos. 4, 5, 6, 7 and 8 prescribed in this *Gazette* shall only be applicable to the importation of goods, which have the date of Bill of Lading/Air Waybill on or after 11 February 2021.
 - 4. Selected ceramic goods, (Classified under the HS Headings of 69.06 and 69.10), as stipulated in the **Schedule II**, shall only be imported based on a minimum of 180-days foreign supplier's credit facility or any other foreign based credit facility, effective from the date of Bill of Lading or Air Waybill of the said goods.
 - 5. Following ceramic goods and their corresponding entries, described in the **Schedule I** of the Imports and Exports (Control) Regulations No. 04 of 2020, published in the *Gazette Extraordinary* No. 2184/21 dated 16 July 2020, as amended, are hereby deleted from that **Schedule I** and such ceramic goods are hereby included into the **Schedule II** of the said *Gazette*.
