IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance, promulgate following Regulations.

REGULATIONS

- 1. These Regulations may be cited as the "Imports and Exports (Control) Regulations No. 08 of 2021".
- 2. The Regulations prescribed in this *Gazette* shall only be applicable to the importation of goods which have the date of Bill of Lading/Air Waybill on or after 11 June 2021.
- 3. Goods described below together with their corresponding entries shall be inserted into the **Schedule I** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017, as amended.
