Regulations

- 1. These Regulation may be cited as the "Imports and Exports (Standardization and Quality Control) Regulations No. 01 of 2022".
- 2. These Regulations shall enter into force with effect from 12th, January 2022.
- 3. Good described below together with their corresponding entries in the **Schedule I** of the Imports and Exports (Standardization and Quality Control) Regulations 2017, published in the *Gazette Extraordinary* No. 2064/34 dated 29 March 2018, is hereby deleted.

- 5. In case of absence of a laboratory facility to issue conformity certificate of Standard for any goods under Serial No. 128 of Schedule I of this *Gazette*, such cases shall be processed only in terms of Regulation No. 4 of the *Gazette Extraordinary* No. 2064/34 dated 29 March 2018 until such laboratory facility, accredited by Sri Lanka Accreditation Board, is etablished.
- 6. If any importers import any goods, mentioned under Serial No. 128, in violation of Regulation 5 above, shall not be permitted for customs clearance and shall be re-exported within Thirty (30) days from the date of refused of permission.
