## PART I : SECTION (I) — GENERAL

### Government Notifications

#### IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969, as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

#### REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 14 of 2022**”.
2. Imports and Exports (Control) Regulations No. 13 of 2022, published in the *Gazette Extraordinary* No. 2294/30 dated August 23, 2022, is hereby amended.



- 2.1 Customs clearance of any goods, specified in the **Schedule I** of the Imports and Exports (Control) Regulations No. 13 of 2022 referred above, which have been shipped on board with the date of Bill of Lading / Airway Bill on or before August 23, 2022, shall be allowed until September 30, 2022.
- 2.2 Importation of any goods, specified in the **Schedule I** of Imports and Exports (Control) Regulations No. 13 of 2022 referred above, which are imported based a Letter of Credit (LC) established on or before August 23, 2022 or an advance payment of minimum 10% of the total amount, effected on or before August 23, 2022, as per the Special Import License and Payment Regulations No. 1 of 2011 published in the *Gazette Extraordinary* No. 1739/3, as amended, shall be allowed for Customs clearance on submission of proof of documents, issued by licensed banks.
- 2.3 Goods, described below together with their corresponding entries shall be inserted into the **Schedule I** of the Imports and Exports (Control) Regulations No. 13 of 2022, referred above.

- 2.4 Goods, described in the **Schedule A of this Gazette** shall be deleted from the **Schedule I** of Imports and Exports (Control) Regulations No. 13 of 2022 referred above.
- 2.5 Notwithstanding the Regulation No. 2 of the Imports and Exports (Control) Regulations No. 13 of 2022, referred above;
- Raw materials or intermediate goods, specified in the **Schedule I of the said Regulations**, not available locally sufficiently and required for any products, which are locally manufactured with minimum of 20% local value addition, shall be allowed to import such essential raw materials or intermediate goods by the Controller General of Imports and Exports on recommendation of the Secretary, Ministry of Industries.
  - Capital goods, specified in the **Schedule I of the said Regulations**, not available locally and required for continued operations of any local industries may be allowed to import such capital goods by the Controller General of Imports and Exports on recommendation of the Secretary, Ministry of Industries.
  - Any vessels and floating structures, machinery, equipment and accessories including parts, specified in **Schedule I of the said Regulations**, which are not locally available but required for fisheries related activities may be allowed by the Controller General of Imports and Exports on recommendation of the Secretary, Ministry of Fisheries.

- d. Franchise holders / operators of any international food and beverage chains, established in the country may be allowed to import goods specified in the **Schedule I of the said Regulations**, except vehicles and auto parts, on a Special License, issued on quarterly basis by the Controller General of Imports and Exports.
- e. Importation of goods specified in the **Schedule I of the said Regulations**, by any Government entities which are providing essential services or supplies or Government Funded Project Entities for the purpose of direct use of such entities or projects including for their operations and maintenance such services or supplies shall be allowed by the Controller General of Imports and Exports on recommendation of the Secretary to the line Ministry in charge of the subject.
- f. Importation of project-related capital Goods, listed out in the **Schedule I of the said Regulations** (*including international brands being imported by registered agents*) for the purpose of any Strategic Development Projects or other projects, which funded by foreign direct investors or local investors, approved under Section 17 of the Board of Investment (BOI) of Sri Lanka Act, No. 4 of 1978, is hereby permitted to be imported on the recommendation of the Director General of Board of Investment. Furthermore, loans of any local banks shall not be used for such importation of project-related capital goods under this Regulation.

In such instances referred (f) above, the importer shall submit a recommendation from the Director General of Board of Investment of Sri Lanka to commercial banks and the Director General of Customs to the effect of payment and Customs clearance purposes.

- g. Importation of goods specified in the **Schedule I of the said Regulations**, by Local Suppliers (Indirect Exporters), who import, process and supply such goods for exporters as specified in Regulation No. 4 (b) of Imports Control Regulations on Payment Terms No. 07 of 2022, published in the *Gazette Extraordinary* No. 2278/21 dated May 06, 2022 as amended, shall be allowed.
- h. Importation of any good specified in the **Schedule I of the said Regulations**, under the Indian Credit Line shall be allowed by the Controller General of Imports and Exports on the recommendation of the Director General, Department of External Resources.
- i. Importation of any goods, specified in the **Schedule I of the said Regulations**, by authorized dealers for the purpose of replacement of defect equipment, machinery or parts or repairs as part of the manufacturer's warranty / guarantee may be allowed by the Controller General of Imports and Exports on case-by-case basis.
- j. Importation of any goods, specified in the **Schedule I of the said Regulations**, by operators of duty-free shops or ship stores for direct sales or bonded warehouse for re-export purposes shall be allowed for Customs clearance by the Director General of Customs.

- 2.6 The Head of the Department of Foreign Exchange and the Head of the Department of Bank Supervisions of the Central Bank of Sri Lanka shall ensure that the commercial banks are carrying out related activities in compliance with the objectives of these Regulations.
- 2.7 Where any commercial bank acts in violation of the provisions of these Regulations, the Director General of Customs shall notify such violations in detail together with relevant documentary evidence to the Head of the Department of Foreign Exchange and the Controller General of Imports and Exports. The Head of the Department of Foreign Exchange and the Controller General of Imports and Exports shall take action as provided for in the law or inform the relevant authority to take appropriate action, as the case may be.
- 2.8 The Controller General of Imports and Exports shall issue appropriate "Operational Instructions" to the Director General of Customs and the licensed banks for effective implementation of these Regulations.
- 2.9 The final decision shall be made by the Controller General of Imports and Exports on any issues arising in relation to these Regulations.

3. Imports and Exports (Control) Regulations No. 10 of 2021, published in the *Gazette Extraordinary* No. 2231/18 dated June 11, 2021 is hereby amended.

3.1 Any other requests for importation of any goods *except HS chapter 87*, specified in the Schedule I to said Regulations, by any enterprises which are not addressed by the Imports and Exports (Control) Regulations No. 10 of 2021 referred above, may be allowed by the Controller General of Imports and Exports Control subject to approval of the Minister in charge of subject of Finance on recommendation of the Secretary to the Treasury for the purpose direct usage, not for trading purposes, of such enterprises, case-by-case basis.

4. Imports and Exports (Control) Regulations No. 05 of 2020, published in the *Gazette Extraordinary* No. 2189/4 dated August 17, 2020, is hereby amended.

4.1 Goods, described below together with their corresponding entries *shall be inserted* into the **Schedule I** of the Imports and Exports (Control) Regulations No. 05 of 2020, where importation of goods listed out in said Schedule has been Temporary Suspended.
