IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969, as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

Regulations

1. These Regulations may be cited as the "Imports and Exports (Control) Regulations No. 24 of 2022".

- 2. These Regulations shall enter into force with effect from December 20, 2022.
- 3. Imports and Exports (Control) Regulations No. 13 of 2022, published in the *Gazette Extraordinary* No. 2294/30 dated August 23, 2022, as amended, is hereby further amended.
