**IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969**

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969, as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

**Regulations**

1. These Regulations may be cited as the “**Imports Control Regulations on Payment Terms No. 25 of 2022**”.
2. These Regulations shall enter into force with effect from December 21, 2022.
3. The Special Import License and Payment Regulations, No. 1 of 2011, published in the Gazette Extraordinary No. 1739/3 dated January 02, 2012, as amended by the Imports Control Regulations on Payment Terms No. 17 of 2022, published in the *Gazette Extraordinary* No. 2300/12 dated October 05, 2022 is hereby further amended.



3.1 Goods described below together with their corresponding entries shall be inserted to the **Schedule IV** of the Special Import License and Payment Regulations, No. 1 of 2011, referred above.

4. The Imports Control Regulations on Payment Terms No. 07 of 2022, published in the *Gazette Extraordinary* No. 2278/21 dated May 06, 2022 as amended time to time is hereby further amended.

4.1 Importation of following goods, classified under the **HS Headings 31.02, 31.03, 31.04 and 31.05** shall be allowed under the Open Account/ Consignment Account payment terms subject to recommendation of the Secretary, Ministry in charge of subject of Agriculture, obtained prior to arrival of such goods at the Ports / Airports of Sri Lanka, during the period of December 21, 2022 to June 21, 2023.

**4.2** Importation of **Maize (HS Code of 1005.90.00)** under the Open Account / Consignment Account Payment terms for the purpose of manufacturing of poultry feed;

- i** by registered poultry feed manufacturers on the recommendation of the Secretary, Ministry in charge of subject of Agriculture obtained prior to arrival of such goods at Port / Airport in Sri Lanka, as authorized by the Regulation No. 5 of the Imports Control Regulations on Payment Terms No. 15 of 2022, published in the *Gazette* No. 2297/79 dated September 16, 2022, as amended is hereby extended until January 15, 2023.
- ii** by any other importer *except those who have referred in regulation No. 4.2 (i) above*, is hereby allowed subject to recommendation of the Secretary, Ministry in charge of subject of Agriculture, obtained prior to arrival of such goods at the Ports / Airports of Sri Lanka during the period of December 21, 2022 to January 15, 2023.

**4.3** The Director General, Sri Lanka Customs shall consult the Secretary, Ministry in charge of subject of Agriculture and Controller General of Imports and Exports on any importation made in violation of the regulation Nos. 4.2 (i) and (ii) above.

**5.** The Controller General of Imports and Exports shall issue appropriate "Operational Instructions" to the Director General of Customs and the licensed banks for effective implementation of these Regulations.
