IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

Regulations

- 1. These Regulations may be cited as the "Imports and Exports (Control) Regulations No. 08 of 2023".
- 2. These Regulations shall enter into force with effect from June 01, 2023.
- 3. The Special Import License Regulations No. 01 of 2023, published in the *Gazette Extraordinary* No. 2312/77 dated January 01, 2023, is hereby amended.

5. Any goods specified in Regulation No. 4 above, arrived at any Sea / Air ports of Sri Lanka on or after June 01, 2023, shall be re-exported to the exporting Country within thirty (30) days from the date of arrival of such goods.

6. To achieve the objectives of these Regulations, the Controller General of Imports and Exports shall issue "Operational Instructions" to the Director General of Customs, licensed banks, or any other relevant authorities.
