IMPORTS AND EXPORTS CONTROL ACT, NO. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-section 4(1), Section 6 and section 14 of the Imports and Exports Control Act No. 1 of 1969 as amended by Act. No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

REGULATIONS

- 1. These Regulations may be cited as the "Imports and Exports (Control) Regulations No. 10 of 2023".
- 2. The Special Import License Regulations No. 01 of 2023, published in the *Gazette Extraordinary* No. 2312/77 dated January 01, 2023, is hereby amended.
- 3. Goods described below together with their corresponding entries shall be inserted into the **Schedule I** of the Special Import License Regulations No.01 of 2023, referred above.

- 4. Notwithstanding the Regulation No. 3 above, importation of goods specified therein shall be allowed for the Custom Clearance subject to an Import Control License (ICL) on the following instances;
 - (a) Goods, which have the shipped on Bill of Lading date on or before June 14, 2023, and arrived on or before June 30, 2023.
 - (b) Goods, which have been imported based on the Letter of Credit, established on or before June 14, 2023, and arrived within 60 days from the date of these Regulations
 - (c) Goods, which have been imported based on an Advance Payment effected on or before June 14, 2023, and arrived within 60 days from the date of these Regulations.
- 5. To achieve the objectives of these Regulations, the Controller General of Imports and Exports shall issue "Operational Instructions" to the Director General of Customs, licensed banks or any other relevant authorities.
- 6. Final decision shall be made by the Controller General of Imports and Exports on any issues arising in relation to these Regulations.
- 7. Import Control License fee, which shall be payable on the following category of goods, shall be inserted into the Schedule I of the Special Imports and Exports Control License fee, published in the *Gazette Extraordinary* No. 1953/28 dated 11 February 2016, as amended.
